2. Water and power. [] Customer provides an outdoor spigot and outlet [] Contractor supplies water

3. Before we arrive. Customer closes windows and doors, moves vehicles and fragile items out of the work area, and keeps pets inside during the work.

4. Pre-existing conditions. Before work begins, Contractor and Customer walk the property and record existing conditions on the walkaround sheet (page 2), with photos. Conditions recorded there existed before work began. Cleaning can make existing conditions more visible.

5. What cleaning may not remove. Rust, oil, paint, efflorescence, hard-water, and some organic stains may lighten without coming out. Oxidized paint may chalk or lift.

6. Plants. Contractor wets and rinses plants near areas cleaned with chemicals.

7. Reporting a problem. Customer reports any concern within 48 hours of completion, with photos, so Contractor can inspect it.

8. Weather. Rain, freezing temperatures, or high wind may move the date. Contractor reschedules at no charge.

9. Cancellation. Customer may cancel up to _____ hours before the scheduled start. Deposit: _____

10. Insurance. Contractor carries general liability insurance. Certificate available on request.
